APPEAL & ERROR — MOTION FOR RULE ON THE CLERK — GOOD CAUSE FOR GRANTING. — An admission by an attorney for a criminal defendant that the record was tendered late due to a mistake on his part, is good cause to grant a motion for rule on the clerk.

Motion for Rule on the Clerk; granted.

PER CURIAM. Petitioner Howard D. Davis, by his attorney, has filed a second motion for a rule on the clerk. His attorney, Robert Meurer, has by affidavit admitted it was his fault that the record was not timely tendered.
