APPEAL & ERROR — MOTION FOR RULE ON THE CLERK — GOOD CAUSE FOR GRANTING. — An admission by an attorney for a criminal defendant that the record was tendered late due to a mistake on his part is good cause to grant a motion for rule on the clerk.

Motion for Rule on the Clerk; granted.

PER CURIAM. The appellant, Leslie Sego, by his attorney, has filed a motion for a rule on the clerk.

His attorney, Joe Kelly Hardin, admits that the failure to file the record in time was due to a mistake on his part.
