[CV-17-355](#). Rickey Tyrone Taylor v. State of Arkansas, from Lee County Circuit Court. Appellant's pro se motions for extension of brief time, for appointment of counsel, and for duplication of motion for appointment of counsel at public expense. Appeal dismissed; motions moot.
