AMENDMENT TO RULE III.

Rule No. III, concerning petitions for rehearing, is hereby amended by adding the following:

The attorney for petitioner shall deliver to the attorney (or one of the attorneys) for the opposite party a copy of the petition and a copy of the brief thereon (if any), or shall file such copies with the clerk of this court for the opposite party; and the clerk shall, when such copies are filed with him for the opposite party, forthwith send the same by mail to the attorney (or one of the attorneys) for such party.
