PER CURIAM. On September 26, 1983, the Court created an Alternate Committee on Professional Conduct, to serve in the rare instances in which the members of the Supreme Court Committee on Professional Conduct consider themselves disqualified from participating in a matter before that Committee thereby enabling the Supreme Court Committee on Professional Conduct to refer the matter to the Alternate Committee. The Alternate Committee was to establish staggered terms of three, four, five, six, and seven years for the lawyer members and terms of three and four years for the non-lawyer members. Thereafter the terms were to be seven years for the lawyer members and four years for the non-lawyer members.

The Alternate Committee met only once, and there is some confusion regarding whether the members actually drew for the staggered terms.

Therefore, the following persons are appointed as members of the Alternate Committee to serve collectively or individually as the situation requires and are requested to draw for staggered terms as set forth above. Thereafter the terms will be seven years for all Committee members.

PER CURIAM. The Supreme Court Library has various volumes of superseded foreign state statutes and no longer has the space to shelve them. The libraries of the Schools of Law of the University of Arkansas at Fayetteville and Little Rock have agreed to accept these volumes on permanent loan.

The library also has a large collection of superseded federal statutes, odd books on subjects other than law, and a collection of foreign primary and secondary materials that are no longer of use to the court, but no institution of higher learning has expressed an interest in receiving a permanent loan of these books.

The Supreme Court Librarian is authorized to make a permanent loan of those books desired by the Schools of Law of the University of Arkansas, and may sell, upon public notice, the remaining books to a reputable law book dealer or any other interested persons.

IN THE MATTER OF RULES OF PROCEDURE OF
THE ARKANSAS JUDICIAL DISCIPLINE AND
DISABILITY COMMISSION

PER CURIAM. Rule 8. L. of the Rules of procedure of the Arkansas Judicial Discipline and Disability Commission is revised to provide as follows:

L. Subpoenas and Summonses. The Commission has the authority to issue summonses for any person(s) and subpoenas for any witness(es), including the judge concerned, and for the production of papers, books, accounts, documents, records, or other evidence and testimony relevant to an investigation or proceeding. Such process shall be issued by and under the seal of the Commission and be signed by the Chairman, Vice-Chairman or the Executive Director. The summonses or subpoenas shall be served in any manner provided by the Arkansas Rules of Civil Procedure for service of process. Upon receiving notice from the Commission of the pendency of a proceeding, the judge concerned shall be entitled to compel, by subpoena issued in the same manner, the attendance and testimony of witnesses, and the production of papers, books, accounts, documents and testimony relevant to the investigation or the proceeding. The Commission shall provide for its use a seal of such design as it may deem appropriate. The Circuit Court of Pulaski County shall have the power to enforce process.
