[CR-78-165](#). Marlon Glenn Hallman v. State of Arkansas, from Pulaski County Circuit Court, First Division. Petitioner's pro se petitions to reinvest jurisdiction in the trial court to consider a petition for writ of error coram nobis and to recall the mandate and for leave to proceed in forma pauperis. Petition to reinvest jurisdiction and to recall the mandate denied; kidnapping sentence void; petition for leave to proceed in forma pauperis moot.
