[CR-15-539](#). Trencie Oliver v. State of Arkansas, from Pulaski County Circuit Court, Fourth Division. Petitioner's pro se petition to reinvest jurisdiction in the trial court to consider a petition for writ of error coram nobis. Petition denied. Hart, J., dissents.

[CV-19-681](#). Municipal Health Benefit Fund v. Ricky Hendrix, Individually and on Behalf of All Arkansans Similarly Situated, from Pope County Circuit Court. Affirmed. Hart, Wood, and Womack, JJ., concur in part and dissent in part.
