Petitioner's pro se petition to reinvest jurisdiction in the trial court to consider a petition for writ of error coram nobis; motion to amend petition to reinvest jurisdiction; motion for appointment of counsel. Petition denied and motion to amend treated as an amended petition and denied; motion for appointment of counsel moot.

Appellants' motion for emergency stay and incorporated memorandum of authorities. Expedited consideration granted; motion for emergency stay granted. (Proceedings of February 28, 2022)

CV-22-124. The Travelers Indemnity Company and Stephen E. Goldman v. Board of Trustees of the University of Arkansas, from Pulaski County Circuit Court, Sixth Division. Appellants' motion for clarification of order on emergency motion for stay and incorporated memorandum of authorities; request for expedited consideration. Appellants' motion to supplement the partial record. Expedited consideration granted; motion for clarification granted as follows: this Court's stay of February 28, 2022, applied to all proceedings in the circuit court case. Wood, J., would clarify that the stay applied only to the disqualification of Stephen E. Goldman. Appellants' motion to supplement the partial record is granted.
