**Court Notes, 2023:**

Effective January 1, 2024, a verbatim record is mandatory, with waiver exception in limited circumstances, on state district court judges presiding over circuit court matters referred pursuant to Administrative Order Number 18.

A proceeding for purposes of Administrative Order Number 4 is considered a hearing, or portions thereof, conducted by the court, reasonable cause determinations pursuant to Rule 4.1(e), first appearances pursuant to Rule 8.1, pretrial release inquiries pursuant to Rule 8.4 and 8.5, and release decisions pursuant to Rules 9.1, 9.2, and 9.3.
